Privacy and Limits to Confidentiality:

Your privacy is of the utmost importance and all reasonable efforts will be taken to protect your personal information. Limits of confidentiality include storing of some personal information (name, address, Emergency Contact) in Counselor's business files; risk of harm to self or others, as determined by Counselor, and any or all mental health crises that are not within the professional scope of Counselor to address. Client agrees to seek appropriate medical help if necessary to ensure emotional and physical safety. Counseling via computer, telephone and other technological means has limits to confidentiality and privacy that Counselor can neither determine nor control.

Release of Liability and Hold Harmless Agreement:

Client agrees to accept these terms and limits, and to hold Rachel Pray, MA and Reiki+Wisdom Energy Healing & Counseling harmless and release Counselor from liability in connection to any and all Counseling and Reiki Energy Healing services whether provided in person or through other any and all other means of communication, including emails, phone calls, texts, Skype, Zoom and other online services.
